

## INSTRUCTIONS FOR AUTHORS

Only manuscripts which describe original work not previously published will be considered for publication in the Bulletin. If accepted, must not be published in any other Journal without permission from the Editor of this Bulletin.

### Types of Manuscripts:

- A- Articles or full papers, which give a concise account of the author(s) work in one of the fields of pharmacy. They should be addressed to specialists with intention of increasing their knowledge in the field of research under consideration.
- B- Notes, which are short articles, presenting concise but complete description of a small rounded-off investigation or of a side part from the main line of investigation, which will not be included in a later paper.
- C- Short communication, which presents work shorter than full papers with the intention of prompt publication on account of the scientific significance of the contents.
- D- Review articles.

### General Instructions:

- 1- Manuscripts must be submitted in triplicate, typewritten double spaced, and on one side only. A 5-cm margin should be left on the left side of all pages, including references, tables and legends to figures.
- 2- Spelling should be consistent throughout all the paper and according to the Oxford Dictionary.
- 3- Footnotes are to be avoided as much as possible.
- 4- Whenever possible, authors should arrange their material in well defined sections: Introduction, Experimental, Results and Discussion.
- 5- All communications should begin with a cover page containing the name(s) of author(s), the name and address of the laboratory of research (**contain the country and post code**), a brief summary and the **keywords**, not exceeding 150 words, stating the objectives of the work and its important findings. The first page of the manuscript contains the same information as the cover page, but not be the summary. This is followed directly by the main text.
- 6- Full papers should contain, on a separate page, a summary in Arabic.
- 7- References should be listed according to their appearance in the text numbered consecutively and typed after the text.  
They are to include initials of the authors and be arranged and punctuated as follows:
  - a) A. P. Simonelli, S. C. Mehta and W. I. Higuchi, (**Title of the paper**), J. Pharm. Sci., 58, 538 (1969).
  - b) T. A. Geissman, "The Chemistry of Flavonoid Compounds" The Macmillan Company, New York, 1962, p. 50.
- 8- The name of periodicals should be abbreviated according to the most recent list of periodicals abstracted by Chemical Abstracts. For economy, abbreviations rather than words are to be used, such as: cm, mm, m, km, cc, ml, g, mg, kg, min, hr, m.p., f.p., cal., kcal, %, expt., Fig., °C.
- 9- Tables should be typewritten on separate pages, one for each Table (**numbering of tables must be such as 1, 2 ...**). Each table should be provided with a descriptive title, making clear the results presented in it. The units in which the results are expressed may be given in the columns, headings, or as footnotes.

- 10- Figures should be made with India ink on white drawing paper of sufficient thickness to reproduce well. Figures should be delivered ready for reproduction. Whenever possible, a line drawing rather than a photograph is preferred. Photographs should be glossy and as rich in contrast as possible. **Numbering of figures must be such as 1, 2 ....**

Reproduction of coloured illustrations is not available.

A short and intelligible legend for the figures should be on separate sheet of paper.

- 11- Structural chemical formulae should be given on white drawing paper with India ink, in a size suitable for reproduction.
- 12- When a manuscript is accepted for publication, authors are encouraged to submit diskette with the final draft.
- 13- Contributions submitted to the Bulletin are charged with a non-repayable consideration fee:

First: Inside Egypt:

- 400 L.E for inside Assiut University.
- 500 L.E for outside Assiut University
- In case of third judgment 200 L.E more.

Second: Outside Egypt

- 100 \$ for research comes outside Egypt.

**Publishing:**

- Authors are entitled to 5 reprints, for each page:
  - 30 L.E from inside Assiut University,
  - 40 L.E from outside Assiut University and
  - 5 \$ outside Egypt.
- 50 L.E to buy one hard copy of the Journal.
